

## SHORT DESCRIPTION OF THE OFFENES:

#### CBI Case:

The CBI case alleges that during the tenure of Sh. Lalu Prasad Yadav as Railway Minister between 22.5.2004 to 22.5.2009 the award of contract to M/s. Sujatha Hotels Pvt. Ltd. for operation of two railway properties by IRCTC was allegedly awarded due to undue favour.

It is alleged that M/s. Sujatha Hotels Pvt. Ltd. of Kochhars had in February, 2005 sold land in Patna to a Company, M/s. Delight Marketing Co. Pvt. Ltd. (DMCPL) incorporated in 1981 (now M/s. Lara Projects LLP) for Rs. 1.61 crores as against alleged price of Rs. 1.96 crores as per then circle rate, apart from alleged payment of less stamp duty.

It is alleged that land purchased from Kochhars by DMCPL in February 2005 was for ultimate benefit of Sh. Lalu Prasad Yadav and family because between 31.05.2010 to February 2014, the shares of DMCPL were transferred in tranches to the family members of Sh. Lalu Prasad Yadav. It is alleged that Sh. P.C. Gupta is a close-associate of Sh. Lalu Prasad Yadav, who was initially in 1981 one of the directors of DMCPL and that the Patna land was transferred to the family of Sh. Lalu Prasad Yadav as a consideration for alleged undue favours to Kochhars in awarding aforesaid contract. The Notice Inviting Tender (NIT) for such contract was issued in 2006.

#### PMLA Case:

As CBI charge sheet contained offences in the schedule of PMLA, on the same allegations, a separate complaint has been filed by PMLA authorities tracing the money for purchase of land to short-term loans raised by DMCPL from an NBFC and its repayment back by raising the capital by issue of preferential shares and later transfer of the shares of the company DMCPL to family members of Sh. Lalu Prasad Yadav.
