On 21.07.2009 after the grant of assents to the demands for grants of aforesaid 14 departments, the rest demands for grants tagged with aforesaid demands for grants were taken up through the process of Guillotine and they were also accepted by the House through voice vote.

On 22.07.2009 and 23.07.2009 Bihar Appropriates Bill (No.-2) was taken up for consideration. Sixteen Hon'ble members of both sides of the House took part in debate and after reply of the Hon'ble Minister-in-charge, Finance, it was passed by the House by voice vote.

On 21.07.2009 the Hon'ble Minister-in-charge, Finance presented the 1st supplementary statement of expenditure for the year 2009-10.

The discussion on 1st supplementary statement of expenditure for the year 2009-10 took place in the House on 24.07.2009. Out of 16 cut motions received, 14 cut motions were admitted and 2 were rejected but no cut motions against the demand of social welfare department was moved in the House because of the disturbance created by opposition members on the issue of adjournment motion. After the reply of Hon'ble Minister-in-charge, the House gave its assent to the demand for grants of the said department. Thereafter, the rest demands for grants were taken up through Guilloitine and were accepted.

The Appropriation Bill relating to the 1st supplementary statement of expenditure for the year 2009-10 i.e. Bihar Appropriation Bill (No.-3) 2009 was introduced in the House on 24.07.2009 itself by the Hon'ble Minister-in-charge, Finance. It was considered and passed by the House on the same day i.e. on 24.07.2009.

#### 13. ZERO HOUR

As per Rule 23(A) of the Rules of Procedure and Conduct of Business of the Assembly, the Hon'ble Members are allowed to avail 20 minutes time immediately after the question hour is over to raise any matter of urgent public importance, if they bring the same in the notice of the Hon'ble Speaker through the Secretary of the Assembly one hour before the sitting of the House commences During this session, on every working day, the matter of urgent public importance were allowed by the Hon'ble Speaker to be raised during the Zero Hour period.

# 14. DECLARATION MADE BY THE HON'BLE SPEAKER ABOUT ACCEPTANCE OF NIVEDAN

During the session, on every working day, Hon'ble Speaker made declarations regarding accepted NIVEDANS and with the consent of the House all total 167 accepted NIVEDANS out of 337 NIVEDANS received were sent to the NIVEDAN committee for enquiry and report. The rest 170 NIVEDANS were found to be not in order and hence they were rejected.

# 15. LAYING DOWN OF PETITIONS (YACHIKA) ON THE TABLE OF THE HOUSE

On 16.07.2009 and 30.07.2009, with permission of the Hon'ble Speaker, the Assembly Secretary laid 30 and 32 Petitions (Yachika) respectively of general Public importance on the table of the House to be sent to the Committee on Petition (Yachika Samiti) for consideration and report.

#### 16. PRIVATE MEMBERS BUSINESS & RESOLUTIONS

On 29th & 30th July, 2009 notices of resoulutions were taken up. All together 141 out of 147 resolutions were put up for consideration. 116 resoultions were withdrawn by the respective Hon'ble Members in view of the assurances given by the Hon'ble Ministers of the respective departments.12 resolutions were accepted and 06 resolutions were rejected by the House and rest 13 (thirteen) resolutions could not be taken up as the Hon'ble Members concerned were absent.

On 29th July, 2009 Shri Shakluni Choudhary, MLA was declared elected as Deputy Speaker of Bihar Legislative Assembly unanimously.

# 18. DEBATE UNDER RULE 94 OF THE RULES OF PROCEDURE & CONDUCT OF BUSINESS

On 17.07.2009, the Hon'ble Speaker permitted the Hon'ble members to debate on the short notice question no.-38 relating to social, financial and educational development of Mahadalit in the state for half an hour, Dr. Ram Chandra Purbey, the Hon'ble member, who had given notice of debate on the issue moved the matter and expressed his views. Thereafter 14 other Hon'ble members from both sides took part in the debate. The Hon'ble Minister Sri Jitan Ram Manjhi gave reply to the debate.

# 19. SPECIAL DEBATE ON THE MATTER OF PUBLIC IMPORTANCE

On 22-07.2009, the House made debate on the matter of public importance i.e. "Serious crisis before the farmers due to awful drought in the state and its remedy" (राज्य में भीषण सुखाड़ से किसानों के समक्ष उत्पन्न गंभीर संकट तथा इसके निदान ।). The debate was made on the notice of the Hon'ble member Sri Ramdeo Verma. It was
