 - d) The tenderer should have a Branch Office in Patna.
 - 2. The Tenderer should have experienced technician as per requirement on its rolls or rolls of its associates specifically trained for IR based simultaneous interpretation system for two languages (English & Hindi).
 - 3. The Tenderer should have minimum five years of experience in doing similar nature of work as mentioned in scope of work and have successfully completed.
 - a) One similar work of value equal to Rs. 3 Lakhs annually.

Technical scores of each technically evaluated bids based on the above criteria would be calculated after evaluation of information and supporting documentation submitted by each bidder. All bidders who have submitted information and documentation as per the tender documents and have scored more than 70 marks on the technical criteria would be considered technically eligible and referred to as Technically Evaluated Responsive Bidders or Pre-Qualified Bidders.

II. INSTRUCTION TO TENDERERS

- 1. The tenderers are required to submit two separate Bids i.e. Technical and Financial, as per prescribed proforma. The two Bids should be submitted in two separately sealed envelopes marked "Technical Bid for IR based simultaneous interpretation system for two languages (English & Hindi), Patna" (Documents must be submitted in spiral binding. Bid submitted in loose sheets will be rejected.) and "Financial Bid for Interpretation System services for 85th All India Presiding Officer's Conference, from 20TH to 21ST January, 2025 at Patna". Both sealed envelope should be put in a third sealed envelope marked "Tender for IR based simultaneous interpretation system for two languages (English & Hindi) for 85th All India Presiding Officer's Conference, from 20TH to 21ST January, 2025 at Patna", before 12th December, 2024 at 3.00 pm.
- 2. Tenders will be opened at 04:00 pm on 12th December, 2024 by a Tender Evaluation Committee constituted for the purpose in the presence of tenderers and /or their representative who may like to be present on given date and time.
- 3. The tenders form must be clearly filled in ink legible or typed. The tender should quote the rates and amount in the figures and as well as in words. In case, there are differences of amount in words and in figures, amount mentioned in words shall be treated correct and final. Alternations unless legibly attested by the Tenderer shall be disqualified and rejected. Tender document, must be duly signed by the tenderer himself / herself, or his / her authorized signatory.
- 4. The forwarding letter and attested copies of the following documents are required to be submitted along with the tender: List of clients with either a Letter and / or Contract award document from clients served or presently being served
- 5. Every paper of the tender should be signed by the Tenderer with seal of Agency/ Firm.
- 6. The agency shall have to deposit Rs. 10,000/- as earnest money deposit (EMD) by way of A/c payee Demand Draft /FD / Bankers Cheque payable at Patna (Refundable till the finalization and award of tender to one of the tenderer) pledged in the name of D.D.O Bihar Legislative Assembly, Patna-15. No cash will be accepted. The amount of EMD should not bear any interest whatsoever, which will be refunded to the un-successful tenderer after award of the work.
- 7. The successful tenderer shall have to deposit (10%) of Contract amount as security deposit in the form of Bank Draft / Bank Guarantee of a Nationalized Bank in favour of 'DDO Bihar Vidhan Sabha Patna' payable at Patna within 15 days after the offer letter is received by the successful bidder / Agency otherwise the award letter will be treated as cancelled. The amount of security deposit will not bear any interest whatsoever.
- 8. The BLA shall pay after the statutory deductions to the contractor at the prevalent rates of such sum as income tax on the income comprised their as per instructions issued by Govt. of India from time to time.

- 9. The BLA reserves the right to have a panel made out of the tenders submitted and in case the agency selected fails to do the job successfully or leaves the job in middle of the contract period, or decline to accept the award due to some reason the next agency will be offered the job however the validity of the panel will be for the period of the award of contract to the first panelist and in case the second in the panel is offered the job the timespan for this will be the remaining period of the first awardee of the contract. In case the successful bidder declines to accept the award or to provide services as per scope of work, the EMD made by him/her shall be forfeited and may also be black listed.
- 10. The BLA reserves the right to cancel / reject full or any part of the tender which tenderer do no fulfill the condition stipulated in the matter.
- 11. Tender once submitted, it will be/would be presumed that the tenderer has understood and accepted all the terms and conditions. No inquiry, either verbal or written, shall be entertained in respect of acceptance / rejection of the tender.
- 12. Any act on the part of the tender to influence anybody in the BLA is liable for rejection of his / her tender.
- 13. Quotation must be unconditional. An alternation or changes in rates in tender document shall be considered as invalid and liable to be rejected.
- 14. Tenders not conforming to these requirements shall be rejected outright and no correspondence thereof be entertained whatsoever.
- 15. BLA reserves the right to accept or reject any bid irrespective of its being lowest by taking into account the interest of the BLA in awarding that contract. Interest of BLA will be paramount and it this regard the decision of the BLA shall be final.
- 16. It is mutually agreed that all differences and disputes arising out of or in connection with the agreement that shall follow the award of the tender shall be settled by mutual discussions and negotiations. However, if such disputes and differences cannot be settled and resolved by discussions and negotiations, the same shall be referred to the Sole Arbite appointed by the BLA whose decision shall be final and binding on both the parties.

III. SCOPE OF WORK

- 1. Providing IR based simultaneous interpretation system for two languages (English & Hindi) for 85th All India Presiding Officer's Conference (20TH & 21ST JANUARY 2025) at Patna on rental basis.
- 2. To install the system 2 days in advance i.e. 18.01.2025 & give trial of the system on 18.01.2025 & 19.01.2025. No extra payment shall be made for such trail.
- 3. Audio input is to be given from the existing DCN system of the BLA.
- 4. Two Mikes and four Headphones to be installed at interpretation booth.
- 5. To fix IR based transmitter & receivers in sufficient number to get the clear voice quality.
- 6. Wiring form transmitter to the interpretation booth shall be done by the firm / organisation without any extra charges.
- 7. The firm / organisation has to keep extra headphone at least 5% of the total quantity for replacement in case of any headphone no working properly.
- 8. The firm / organisation has to depute two skilled persons during conference days from 8:00 AM to the end of days session.
- 9. The persons deputed at site should have enough technical knowledge of the system & should be able to carry out works independently.
- 10. The firm / organisation should keep sufficient spares during conference period to avoid any malfunctioning of the system.

- 11. Existing installation of BLA can be seen & checked before quoting. Any repairs, settings, installation of minor spares, required for successful operation will be in the scope of the firm / organisation without extra charges.
- 12. The firm / organisation is required to keep the system in proper working condition. In case of non working of system for more than 10 minutes during the conference, penalty amounting to Rs. 10,000/- per 10 minutes will be imposed. If man power is found absent then a penalty of Rs. 15,000/- per day or part hereof is imposed.
- 13. The firm / organisation shall keep sufficient T&P at all time during working hours at site for satisfactory maintenance of the system.
- 14. Complete Interpretation system shall be installed on returnable basis, firm / organisation has to take back his system after the conference.
